RE: CEASE AND DESIST, WITHIN 3 DAYS, ON UNSCIENTIFIC AND EXTREME COVID POLICIES THAT ARE HARMING AND/OR KILLING MILLIONS OF FILIPINOS AND DESTROYING THE COUNTRY (WITH NOTICE OF LIABILITY)

I am writing as part of a large national network of concerned citizens, their supporters, and digital sympathizers numbering in the hundreds of thousands. We are part of the various organizations seeking to inform the government regarding the dangers of the vaccines that are mostly being given without the proper information and consent of many Filipinos as required by law. We are all doing our part of inform our LGU of this action.

On 18 October 2021, Nicanor Perlas of Covid Call to Humanity, a key leader in this national network, issued a letter to the Duterte Government to **cease and desist** from unscientific and extreme Covid policies that are killing and harming Filipinos as well as destroying the country in the process. He has encouraged all concerned citizens to do the same for their province and/or city or town.

The enclosed **Cease and Desist** document, which is also a **Notice of Liability**, highlights the following problems with current Covid policies including extreme lockdowns, quarantine-related measures and forced mass vaccinations:

- We had **no excess deaths in 2020**; hence **no health emergency**.
- There are **safe treatments available** but suppressed by government.
- Our **immune system is 2700% more protective** than vaccine-induced immunity.
- We are creating a **real epidemic of the vaccinated**. The vaccinated still get infected and die from the disease. They are also super spreaders of the disease. Worst, they incubate variants.
- The **young have a survival rate of 99.997%** yet government is running after them to inject them with **vaccines that have already killed millions worldwide**.
- Recent global investigations are showing that **these are not vaccines but sophisticated bioweapons**. Military officers have already died.

- The Duterte Covid mandates violate over 30 articles of the Constitution and **are illegal**, including the issuance for the EUAs for the vaccines.

This is going to be worst than the Dengvaxia scandal and the Extra Judicial Killings (EJK) combined. In the Philippines, thousands have already died and hundreds of thousands seriously injured. **Millions are dying and over a hundred million are already injured around the world.** This is genocide. Yet the DOH keeps on lying to the Filipino people that the vaccines are safe and effective.

The attached Cease and Desist document cum Notice of Liability is 86 pages long with 227 references that back up the claims of this notice. It highlights many scientific discoveries and news items that are not known to most Filipinos due to massive media disinformation and censorship that is going on. **Taiwan, for example, is reporting more deaths from the vaccinated than all their COVID-19 deaths.**

In addition to all the constitutional and legal violations we have mentioned in our Cease and Desist letter to the Duterte Government, promoting similar unscientific and extreme covid policies will further make you liable for violating the “**General Welfare**” provision of the **Local Government Code** that mandates you to advance, in the your area of jurisdiction, policies that are healthy for the people.¹ We are requesting you to stop the massive harm and injustice that is being perpetuated right now in our country through various forms of lockdowns and forced or coerced vaccine mandates.

This letter also serves as a **Notice of Liability**. Failure to immediately Cease and Desist, within three days, as part of your constitutional duty, on the massive fraud and *de facto* murders taking place, would open you to whatever legal remedies are available to all aggrieved sectors of society.
