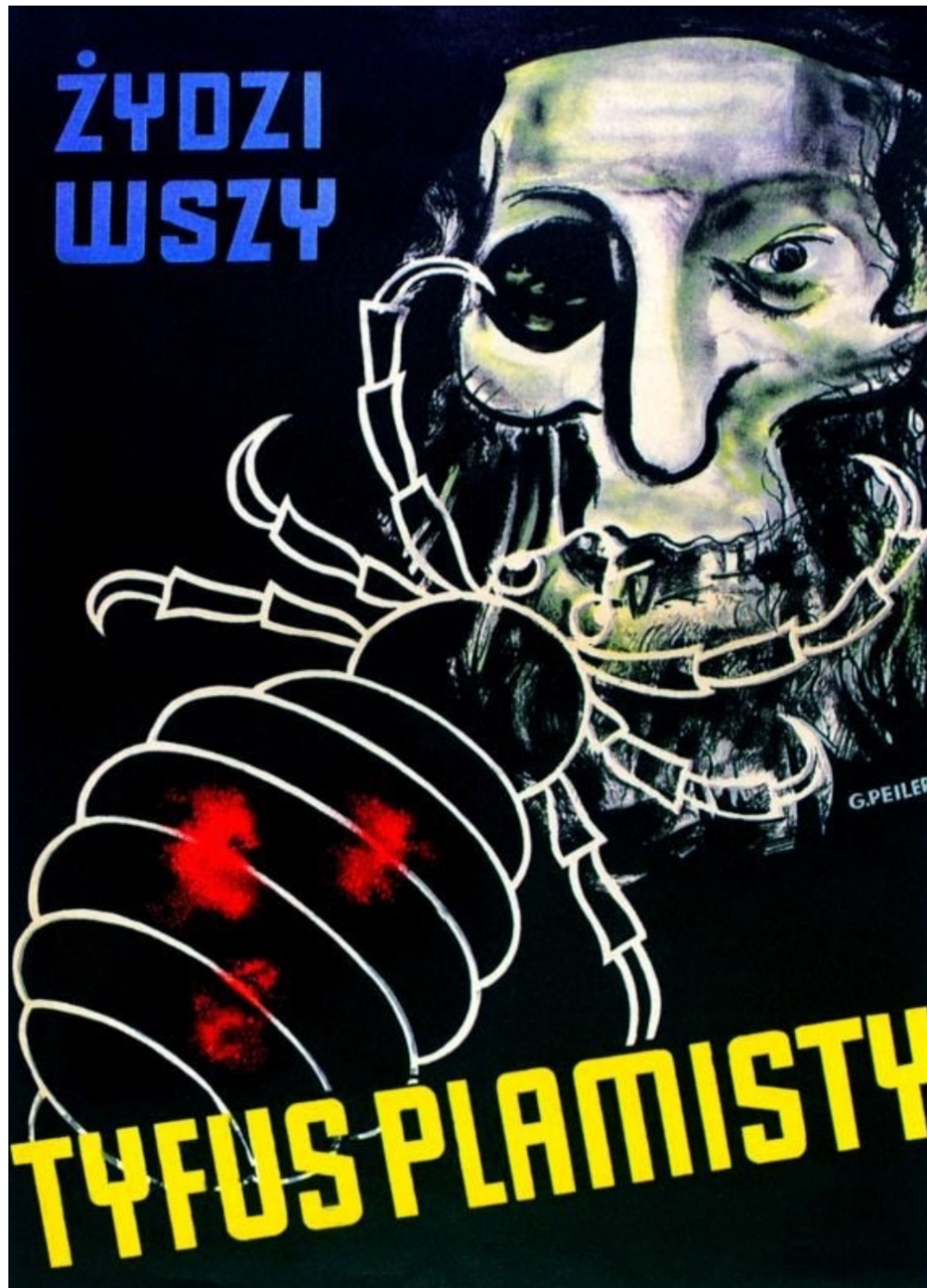

STOP HOLOCAUST

Ladies and Gentlemen,

We, the survivors of the atrocities committed against humanity during the Second World War, feel bound to follow our conscience and write this letter.

It is obvious to us that another holocaust of greater magnitude is taking place before our eyes. The majority of the world's populace do not yet realize what is happening, for magnitude of an organized crime such as this is beyond their scope of experience. We, however, know. We remember the name Josef Mengele. Some of us have personal memories. We experience a déjà vu that is so horrifying that we rise to shield our poor fellow humans. The threatened innocents now include children, and even infants.

Why is IATF Resolution No. 148-B so dangerous?

Purpose:

“to *increase the demand* for COVID-19 vaccination, regardless of brand” (8th whereas clause)



Why is IATF Resolution No. 148-B so dangerous?

It declares the COVID-19 vaccines to be *safe and effective*. (4th whereas clause)



Why is IATF Resolution No. 148-B so dangerous?

It compels **employers** to require all their employees who are tasked to do on-site work to be fully vaccinated. This includes all workers in the public transport sector.
(Paragraphs A, B)



Why is IATF Resolution No. 148-B so dangerous?

It strongly enjoins **LGUs** to issue orders or ordinances “to *ramp up demand for vaccination*” and *incentivize full vaccination*.
(Paragraph D)



Why is IATF Resolution No. 148-B so dangerous?

It creates a distinction between the vaccinated and unvaccinated, and ***legalizes discrimination*** against the unvaccinated.



Why is IATF Resolution No. 148-B so dangerous?

It expressly states that **public and private establishments** can “validly refuse entry and/or deny service to individuals who remain to be unvaccinated or are merely partially unvaccinated, despite being eligible for vaccination.” (Paragraph C)

Why is IATF Resolution No. 148-B so dangerous?

Government agencies are “enjoined to implement measures *prioritizing fully vaccinated individuals* availing of government programs and services.” (Paragraph G)



Why is IATF Resolution No. 148-B so dangerous?

Unvaccinated employees are required to undergo *RT-PCR tests* regularly *at their own expense*.



Why is IATF Resolution No. 148-B so dangerous?

It *impliedly* declares vaccinated individuals to be *immune from COVID-19* by exempting them from testing requirements.



Why is IATF Resolution No. 148-B so dangerous?

It states that *only the Provincial/Municipal/City Health Office can issue medical clearances* that will serve as “sufficient and valid proof of ineligibility for vaccination.” (Paragraph F)

usurps legislative power.**

Republic Act No. 11525

Section 2 (c):

“...the State shall undertake a COVID-19 Vaccination Program with the following objectives:

(c) Recognize the **experimental nature of COVID-19 vaccines** available in the market and compensate any serious adverse effects (SAEs) arising from the use of COVID-19 vaccine, experienced by people inoculated through the COVID-19 Vaccination Program”



Republic Act No. 11525

Section 12:

“... the vaccine cards shall not be considered as an additional mandatory requirement for educational, employment and other similar government transaction purposes.”

“Individuals vaccinated against COVID-19 as indicated in the vaccine card shall not be considered immune from COVID-19, unless otherwise declared by the DOH based on reliable scientific evidence and consensus.”

Article III, Section 1, Philippine Constitution

“No person shall be deprived of ***life, liberty, or property*** without ***due process of law***, nor shall any person be denied the equal protection of the laws.”

Forced vaccination violates human rights.

Every human being has the **inherent right to life**. This right shall be protected by law. No one shall be arbitrarily deprived of his life.

(Article 6.1, International Covenant on Civil and Political Rights)



Forced vaccination violates human rights.

No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment. In particular, ***no one shall be subjected without his free consent to medical or scientific experimentation.***

(Article 7, International Covenant on Civil and Political Rights)



Forced vaccination violates human rights.

Everyone shall have the right to ***freedom of thought, conscience*** and religion.

(Article 18.1, International Covenant on Civil and Political Rights)



Forced vaccination violates human rights.

No one shall be subject to coercion which would impair his freedom to have or to adopt a religion or belief of his choice.

*(Article 18.2, International Covenant
on Civil and Political Rights)*



Public emergencies
cannot restrict or remove
these fundamental rights.

The right to life, the right to not be subjected to medical experimentation without consent, and the right to freedom of thought & conscience *cannot be derogated from even during times of public emergency.*

(Article 4, International Covenant on Civil and Political Rights)



The *discrimination* between the vaccinated and unvaccinated *violates human rights.*

Forced vaccination violates human rights.

All persons are equal before the law and are entitled without any discrimination to the equal protection of the law. In this respect, the law shall prohibit any discrimination and guarantee to all persons equal and effective protection against discrimination on any ground such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status. (*Article 26, ICCPR*)



The *discrimination* between the vaccinated and unvaccinated is *unconstitutional*.

Article III, Section 1, Philippine Constitution

“No person shall be deprived of life, liberty, or property without due process of law, nor shall any person be denied the **equal protection of the laws.**”



The discrimination between the vaccinated and unvaccinated has *no valid scientific & factual basis.*

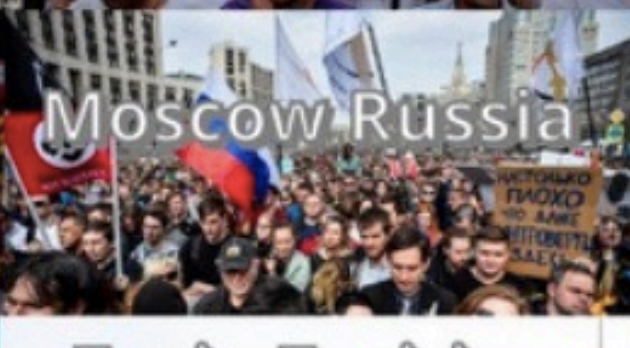
