REPUBLIC ACT (RA) 11525

SECTION 12. COVID-19 Vaccination Program Act of 2021

The vaccine cards shall not be considered as an additional mandatory requirement for educational, employment and other similar government transaction purposes.

In addition, **SECTION 12** also provides that...

Individuals vaccinated against COVID-19 as indicated in the vaccine card shall not be considered immune from COVID-19 unless otherwise declared by the DOH based on reliable scientific evidence and consensus.


TO DATE:

No such evidence has been scientifically and conclusively reached. Therefore, since vaccinated individuals are not immune from COVID-19, they are in the same category as those unvaccinated. **There is no substantial distinction between the vaccinated and unvaccinated that would warrant imposition of restrictive measures and discrimination on the unvaccinated.**

The City Legal Office (CLO) of the City of Cebu made a bold move, a rare one in today's oppressive times. They upheld the law and protected our human rights to make choices for our health and that of our families.

In a legal opinion statement to the Sangguniang Panlungsod on the "No VAX No Entry" policy (also known as the Oplan Puyo Gihapon) implemented by the City Government of Cebu, the Legal Office submitted that the enactment of executive orders no. 157 and 158 with the said policy "is not advised as it may violate constitutional rights, in the absence of a national law implementing the same" and therefore, the enactment of the ordinances regarding such policy should not be carried out. (Atty. Joy Ivey O. Ong, Handling Legal Officer and Atty. Eugene C. Orbita, Approving Legal Officer)

This opinion statement was drawn up at the instruction of the Cebu City Council in response to a presentation by the Concerned Cebuanos for Life & Liberty to the Council protesting the executive orders as discriminatory and violating the equal protection clause.

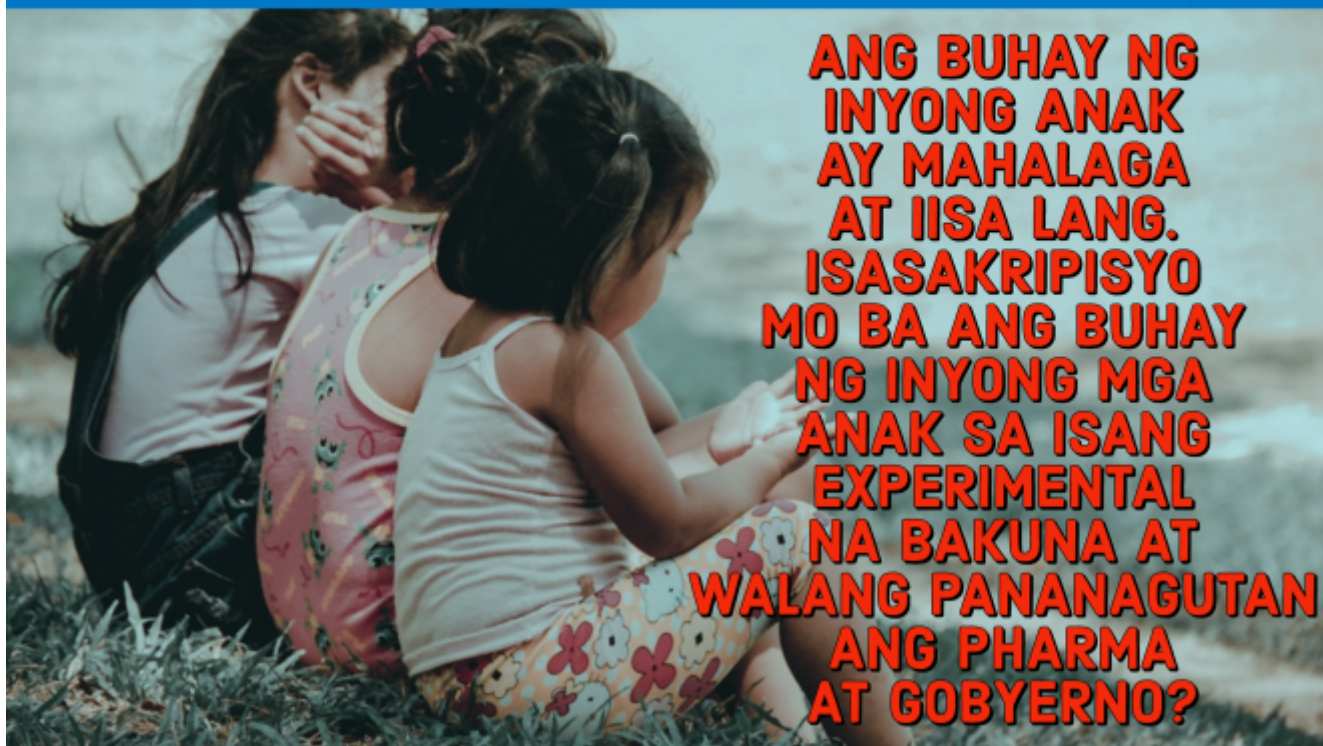

Seksyon 2(C)
