### **EXECUTIVE SUMMARY**

The world health issues around Covid have changed dramatically in the last few weeks. As top policy makers of this country, we assume that you truly seek the health and welfare of the Filipino people. Thus, being honorable Senators of the Republic, you will surely be interested in these significant global developments highly relevant to SB1869.

SB1869 intends to place the Philippines under the control of the World Health Organization (WHO) in the event of a global pandemic. SB1869 also intends to strengthen the DOH on the assumption that DOH did a good job in managing the Covid crisis in our country. **But what if the country's Covid response was a massive failure**?

Your bill is out of touch with current world developments. Countries are starting to question and reject the WHO proposed treaties and amendments. Official government data, whistleblower information and scientific studies reveal that as

many as 13 million people have died from the Covid vaccines and the health of tens of millions more are being seriously compromised with these experimental and unproven vaccines.

You are not learning about these developments because global and local media are heavily censored to hide the truth from the general public. We will specify the top secret censorship and disinformation programs that governments and Big Tech have rolled out on the Covid issue.

SB 1869 has to be seriously revised if it is not to bring irreparable harm to the Filipino people. The only way to do that is to take SB 1869 back to the Committee level where public hearings can be held. If not, come out with a totally new bill that promotes the good intention of SB 1869 and avoids all the pitfalls due to inadequate vetting of scientific data and world developments.

## Nations Reject the WHO and/or Its Treaty Instruments

#### Slovakia

In an unprecedented move, the newly elected Prime Minister of Slovakia, Robert Fico, announced in early December 2023 that **Slovakia rejected the WHO Pandemic Treaty**. He blamed the deaths and serious harms from Covid vaccines as the **'scandalous consequences of mass vaccination'**. In this context, he labelled the WHO Treaty as a **product of 'greedy pharmaceutical companies**'. (Emphases added.)

Furthermore, he gave a warning that is of topmost importance for law makers around the world. "... I also very clearly declare, that SMER Slovakian Social Democracy (the ruling political party) will NOT support the strengthening of World Health Organization's powers at the expense of sovereign states in managing battles against pandemics." (Emphases added.)

In short, Slovakia's rejection of the WHO Pandemic Treaty were based on three reasons: a) the Covid vaccines killed and harmed people; b) these vaccines are the product of "greedy" Big Pharma who do not really care about the health of people; and c) the treaty erodes the sovereignty of nations.

You will note that these are precisely the reasons why Covid Call to Humanity (CCH) has been warning the Senate in its past three Briefing Papers. # New Zealand

In October, New Zealanders voted in a new government. This coalition government agreed not to approve the WHO proposed amendments to its International Health Regulations (IHR). This dealt a blow to one of the two major instruments of the WHO to legally bind countries to highly questionable policies. See CCH Briefing Paper 1 cited in Footnote #2 for more details.

Here is the language of the Agreement between different political parties in New Zealand.

- "Ensure, as a matter of urgency in establishment and completion, a full scale, wide ranging, independent inquiry conducted publicly with local and international experts, into how the Covid pandemic was handled in New Zealand, including covering:
  - o Use of multiple lockdowns,
  - o Vaccine procurement and efficacy,
  - o The social and economic impacts on both regional and national levels, and
  - o Whether the decisions made, and steps taken, where justified.
- "Ensure a 'National Interest Test' is undertaken before New Zealand accepts
  any agreements from the UN and its agencies that limit national decisionmaking and reconfirm that New Zealand's domestic law holds primacy over
  any international agreements.
- "As part of the above, by 1 December 2023 reserve against proposed amendments to WHO health regulations to allow the incoming government to consider these against a "National Interest Test."<sup>3</sup> (Emphases added in all quoted paragraphs.)

From the very beginning, CCH has pleaded to the Senate to conduct similar hearings to determine whether or not to give more powers to DOH in light of the latter's actual management of the Covid emergency in the country. The New Zealand government has provided a powerful cautionary example of how to handle both national and international policies connected with advancing the true health of a people. ### **Estonia**

Estonia went much further than Slovakia and New Zealand. The **Estonian Parliament not only rejected the WHO Pandemic Treaty**. It also sent a formal communication to WHO that Estonia does not accept the proposed amendments to the WHO International Health Regulations. **In addition, Estonia rejected giving additional financial support to the WHO.**<sup>4</sup>

As will be seen below, the media is heavily controlled by corporate, government, intelligence and military interests. One has to rely on mainstream alternative media sources to get the news. But one still needs to determine the authenticity of the news story by checking out the original sources being cited.

### Reasons for the Increasing Rejection of the WHO

A major reason for these rejections is that the Covid vaccines have now been clearly and scientifically demonstrated to be responsible for the death of millions of people around the world. In addition, millions more have been seriously harmed by the vaccines. Furthermore, WHO was complicit in the aggressive promotion of these vaccines that were labeled "safe and effective" by governments around the world including our own DOH.

#### Bombshell Information from New Zealand: The Covid Vaccine Killed Thousands

On December 2, 2023, Barry Young, the designer and top data administrator from the Ministry of Health of New Zealand released rare and unprecedented data from the Covid vaccine experience of his country. This is the first report-level release of any official government information around the world. Thus, the findings will be difficult to dismiss as hearsay or a mere anecdote. The New Zealand data report proved, beyond doubt, that the Covid vaccines killed a lot of people from New Zealand.

Kiwi4Justice, a civil society organization in New Zealand, worked closely with the lawyer who facilitated the release of the official New Zealand data. Kiwi4Justice provides horrifying details about the vaccination nightmare in New Zealand. Emphatically Kiwi4Justice called the Covid vaccine rollout, not only a crime but a "massacre".

"In just one particular vaccination centre in Invercargill, 51 people were vaccinated within the space of just two hours. All 51 are now dead. Out of the 837 people who were vaccinated at another vaccination centre, 253 of them are now dead. 30% of everyone who was vaccinated at that centre are now dead. At another vaccination centre, of the

923 people vaccinated there, 276 are now dead. There were numerous vaccination centres around the country that had mortality rates at this sort of level of 30%. This is compared to the normal average mortality rate of just 0.75%, which is what we should be seeing. The data also shows how many fatalities were linked to each individual vaccinator. One vaccinator had a mortality rate of 25%. One in four people that got the vaccine from that vaccinator is now dead. Other vaccinators were similar. Their vaccine batches were literally death batches. These numbers are simply off the scale and impossible to interpret any other way than a vaccine massacre."

The whistleblower who is familiar with statistics, calculated the "probability of these deaths not being from the COVID-19 vaccine are 100 billion to one". (Emphasis added.) That is, one can roll a dice one hundred billion times and you will get only one chance that it was not the vaccines that killed people.

Here is a graphic presentation of the data cited above. The Vaccinator Name refers to the person who injected the Covid vaccines. Total Vaccinated refers to the total number of individuals he/she vaccinated. Death count records those vaccine recipients who died after vaccination. Ratio percentage captures the percent of those who died from the vaccination given by the vaccinator.

# **More Explosive Vaccine Deaths**

Steve Kirsch is a MIT billionaire turned organizer of a scientific group analyzing Covid death and injurity statistics from various kinds of government data. Kirsch revealed that he and the whistleblower had been in touch weeks before the latter's data was publicly released. Kirsch wanted to make sure the whistleblower data was accurate.

Using the New Zealand data, and combining this with other reputable data sources that Kirsch had already previously uncovered, including the US Medicare data, Kirsch calculated that the **Covid vaccines killed 1 person per 1000 doses** in a standard population.<sup>6</sup>

In the US, that would mean the Covid vaccines killed 675,000 Americans. Using this 1 in 1000 doses factor, Kirsch also calculated that, at least, **Covid vaccines killed around 13 million people around the world.**<sup>7</sup>

We can now do an approximate calculation of New Zealand's death due to the Covid vaccines. New Zealand administered a total of 12 million doses as of April 4, 2023.8 Based on the Kirsch 1 death/1000 doses factor, the Covid vaccines **killed 12,000 New Zealanders.** 

### Covid Vaccines Most Likely Killed 186,000 Filipinos

Covid vaccines are Covid vaccines. They are the same everywhere. We can now use the New Zealand + Kirsch data to obtain an approximate idea of how many Filipinos most likely died from the Covid vaccines.

DOH's FDA gave the figure of 181,645.251 million doses as of September 30, 2023 report.<sup>9</sup> Using the Kirsch factor cited above, **this translates to approximately 181,000 Filipino deaths due to the Covid vaccines.** 

If this looks excessive, take a look at the excess deaths reported by the Philippine Statistics Authority. According to the PSA, the Philippines had around 258,000 excess deaths in 2021.<sup>10</sup> PSA tried to explain that these excess deaths were attributable mostly to heart-related diseases, cancers, and viral infections, including from SARS-CoV-2.<sup>11</sup>

But these other deaths are exactly the kind of collateral damage or serious side effects of the Covid vaccines.<sup>12</sup>

However, these deaths, even if it were true, does not explain the hundreds of thousands of deaths that still remain. Most likely, these are vaccine-related deaths when one considers the data provided by the government whistleblower from New Zealand and the additional data provided by Steve Kirsch as discussed above.

DOH has denied and continuous to deny that the Covid vaccines were responsible for these excess deaths. However, DOH has not been able to point to any satisfactory reason for these highly abnormal excess deaths in the Philippines.

Marshalling the findings of New Zealand and the US and elsewhere, there is strong evidence that the culprit for these excess deaths are the Covid vaccines. If they are not, the Senate should investigate what on earth is going on. For as pointed out in our earlier Briefing Paper, <sup>13</sup> even the WHO has calculated that the global excess deaths have reached 14.83 million. <sup>14</sup>

Is it not an interesting, nay a damning coincidence that the Kirsch data is showing 13 million deaths due to the Covid vaccines and, based on different independent calculations, the world has experienced 13 million deaths just at the time of the massive global roll out of the Covid vaccines.

Meanwhile, insurance companies are also showing massive spikes in death claims during the height of Covid vaccinations. This evidence is contained in Edward Dowd's new book, "Cause Unknown: The Epidemic of Sudden Deaths in 2021 and 2022, points to the massive evidence linking mass vaccinations with Covid vaccines as the most likely cause for these excess deaths. Dowd was a trend analyst expert who managed \$14 billion for Blackrock, which latter manages \$10 Trillion worth of assets.<sup>15</sup>

There are more very disturbing data that CCH will present in its next Briefing Paper. But let us listen to the New Zealand whistleblower why he did what he did. It is a perfect introduction and transition to another huge elephant sitting in the room which has been totally ignored by mainstream media and government regulators, agencies, and oversight bodies.

Here are Berry Young's words: "I am pro-choice in terms of whether to be vaccinated or not. I believe in the fundamental freedoms of people. People should not be forced to take vaccines against their will. I felt bad when the government started mandating the vaccines. Such an act is against everything I thought about Western civilization.

We have been living in an Orwellian nightmare for the last two years: the lockdowns, vaccine passports, the shutting down of people with different perspectives, the banning of people from Facebook, and so on. Science is an evolving thing. It is never settled.

One can only wish that more brave and ethical government officials like him would start revealing the important Covid data they are hiding from the public. If more and more whistleblowers emerge, then the Covid nightmare will be fully revealed and the right consequent actions taken.

### **Controllers Do Not Want Law Makers to be Aware of These Developments.**

Most likely, Senators may wonder why they have not heard these developments in the mainstream news. The simple and direct answer is that a massive network of institutions has formed an alliance to take down information on Covid that challenges the mainstream narrative.

Many already suspected this in the early days of the Covid lockdowns when social media banned their posts and mainstream media refused to carry news reports that challenged the Covid narrative that was coming out from these institutions. CCH, itself, had direct experiences of being banned by both mainstream and social media.

But their worst fears were confirmed when Elon Musk bought Twitter, now called X, and tasked a group of independent journalists to examine then Twitter files and shed light on the extent of the censorship.

Their findings confirmed their worst nightmare. The Twitter files revealed that both Big Pharma and government colluded to pressure social media platforms to censor alternative scientific perspectives on Covid.<sup>16</sup>

Independent credible journalist started calling this collusion between Big Business and Government as the Censorship Industrial Complex. Here is how they described it.

The Censorship Industrial Complex is "a network of over 100 government agencies and nongovernmental organizations that work together to urge censorship by social media platforms and spread propaganda about disfavored individuals, topics, and whole narratives".<sup>17</sup>

US Congressional Hearings have also traced the origins of this complex even before the Covid crisis. Then it was called the EIP or the Election Integrity Partnership. The EIP manipulated narratives around the 2016 election. The Congressional Subcommittee on the Weaponization of the Federal Government reported:

"Created in the summer of 2020 'at the request' of the Cybersecurity and Infrastructure Security Agency (CISA), the EIP provided a way for the federal government to launder its censorship activities in hopes of bypassing both the First Amendment and public scrutiny.

Under the EIP, Stanford University, in partnership with the Department of Homeland Security and the Department of State, worked to censor the digital speech of Americans.<sup>18</sup>

But these efforts were just warm up. Recently, a whistleblower released a new throve of confidential documents showing the existence of the Cyber Threat Intelligence League or CTIL. The aim of the CTIL was to create a global censorship of digital speech that did not concur with chosen narratives promoted by the federal governments of the US and UK military contractors.

"The whistleblower's documents describe everything from the genesis of modern digital censorship programs to the role of the military and intelligence agencies, partnerships with civil society organizations and commercial media, and the use of sock puppet accounts and other offensive techniques.

"'Lock your shit down,' explains one document about creating 'your spy disguise.'

"Another explains that while such activities overseas are "typically" done by "the CIA and NSA and the Department of Defense," censorship efforts "against Americans" have to be done using private partners because the government doesn't have the "legal authority." 19

Amidst all these, more evidence from confidential documents has also surfaced showing that the Biden government paid media to get their preferred Covid vaccine story out to the public.

"Hundreds of news organizations were paid by the federal government to advertise for the vaccines as part of a "comprehensive media campaign," according to documents TheBlaze obtained from the Department of Health and Human Services. The Biden administration purchased ads on TV, radio, in print, and on social media to build vaccine confidence, timing this effort with the increasing availability of the vaccines."<sup>20</sup>

As a result of this de facto bribe money, mainstream media would often suppress other, more truthful narratives about the Covid vaccine and instead peddled the disinformation coming out from the government and Big Pharma instead.

The WHO is also wanting to control "disinformation" which they understand as any information that goes against the narrative of the WHO even if said information is truthful as has happened in the case of Covid vaccine deaths that challenged the WHO and DOH narrative of "safe and effective". See Article 18 of the WHO Pandemic Treaty.<sup>21</sup>

### Implications for Domestic Provisions of SB 1869

The implications of all the above developments for SB 1869 are obvious. One cannot rush a bill pending a more thorough investigation of all the claims of DOH regarding "safe and effective" Covid vaccines and lockdowns. Regarding the latter, scientific studies clearly show that the lockdowns offered very little benefits if any but were clearly devastating in terms of human physical and mental health as well as its effects on the economy.

# SB 1869: Disaster and Chaos Waiting to Happen

Based on all the above facts, it is clear that SB 1869 will not help the future pandemic response of the country. Deaths due to Covid vaccines will continue. The Covid vaccines are not safe and effective. They never were.

Worst, SB 1869 will hand over our national sovereignty to the WHO, which will use the treaty and amendments to its International Health Regulations to install a global medical dictatorship. Based on its proposed treaties and amendments which we have spelled out in great detail in Briefing Paper #1,<sup>22</sup> WHO has sinister control agenda pretending to be a benign health initiative. It will abolish democracy in our country.

The One Health provision in the Treaty will give the WHO a legal pretext and power to declare continuous emergencies and, hence, permanent lockdowns and forced vaccinations, not to speak of draconian surveillance measures.<sup>23</sup>

In the end, Honorable Senators, you will be guilty of treason for handing over our national sovereignty to a foreign institution. Most likely, your good names will be tainted forever as one of the twenty four (24) who betrayed the nation. You will become
