# CCH BRIEFING PAPER ON SB1869, No. 5

RE: 49 US SENATORS WRITE BIDEN TO STOP W.H.O. POWER GRAB

COVID VACCINES RESPONSIBLE FOR 181,000 OF THE 297,000 EXCESS DEATHS REPORTED BY THE PHILIPPINE STATISTICS AUTHORITY AS DOH CONTINUES TO DENY DISASTER

SB1869 WILL REWARD W.H.O. AND "SAFE AND EFFECTIVE" DOH LIARS WITH EVEN MORE POWERS TO CONTROL AND KILL MORE FILIPINOS

Before anything else, Covid Call to Humanity (CCH) wants to express words of appreciation. Thank you, Hon. Senators, for not rushing the enactment of SB 1869 into law. That was prudent on your part. All of the warnings and facts that we have submitted in the past year via **four (4) Briefing Papers**, and which your office have received, have stood the test of time.

Meanwhile, many developments have surfaced that need your urgent attention. We will only highlight some of the most dramatic developments relevant to SB 1869 in recent months.

We already mentioned that some countries have already expressed their lack of support for the WHO and its agreements.<sup>1</sup> The latest is the bombshell rejection of the WHO agreements by forty-nine (49) US Senators. There is something in these WHO agreements that have stirred normally cautious US Senators into action.

#### 49 US Senators Write Biden: Withdraw Support from W.H.O. Agreements

Government officials via the World Health Assembly in May 2024 will decide whether to approve or reject two instruments that the World Health Organization (WHO) is attempting to control the world with. These are the Amendments to the International Health Regulations (IHR) and the new Pandemic Treaty (collectively, WHO Agreements).

The situation has further worsened for the WHO Agreements. Just recently, on May 1, 2024, forty-nine (49) US Senators wrote a letter to Biden asking the latter to withdraw the support of the US government for the WHO Agreements. (See scanned copy of the letter of the US Senators below.)

The WHO's failure during the COVID-19 pandemic was a total as it was predictable and did lasting harm to our country. The United States cannot afford to ignore this latest WHO inability to perform its most basic function and must insist on comprehensive WHO reforms before even considering amendments to the International Health Regulations or any new pandemic related treaty that would increase WHO authority. ... (Emphases supplied.)

It is instructive how the letter of the US Senators echo quite a number of points that CCH has made in its four Briefing Papers. Compare the statements of the US Senators above with CCH statement made in its very first Briefing Paper.<sup>2</sup>

The Senate introduced SB1869 with the intention of overcoming the trauma of three years of COVID-19 health crisis. This is a laudable intention and should garner the gratitude of Filipinos. Finally, there is a possibility of a more scientific and rational approach to the pains of a pandemic crisis.

Unfortunately, a detailed analysis of the bill ... shows that SB1869 will achieve the opposite effect. SB1869 will perpetuate all the massive and dangerous mistakes of the DOH, FDA, IATF, Office of the President, and other agencies -- mistakes that have destroyed the lives, the jobs, the livelihood and the mental health of millions of Filipinos.

SB1869 will not only institutionalize or make permanent all these costly mistakes. It will also subject the Filipinos to new kinds of punishments and ordeals and

even new forms of death. Worst, SB1869 will destroy the country's democracy and help usher in a medical dictatorship under the control of the World Health Organization (WHO) with the blind support of the DOH and the to-be-established Philippine CDC.

The US Senators pointed out to the WHO was violating its own rules to rush an incomplete and fragmented treaty. This is now a reality that is alarming nations who are awake to WHO's power grab.

Article 55 of the IHR requires the text of any IHR amendment to be communicated to member states at least four months before the WHA at which they are to be considered. As the WHO has still not provided final amendment text to member states, we submit that the IHR amendments may not be considered at next month's WHA. Some of the **over 300 proposals** for amendments made by member states **would substantially increase the WHO's health emergency powers and would constitute intolerable infringement upon U.S. sovereignty.**...

It then goes on to state that **the WHO should abide by its own rules** and should not try to get member states to vote on the IHR amendments which are not in their final form. If a proponent is rushing a proposal, one can smell something problematic is afoot.

CCH warned Senators that SB 1869 would have a similar impact on Philippine sovereignty. CCH listed a list of red flags that were being debated inside the WHO.<sup>3</sup>

List of Issues ...

- Change the role of WHO from advisory to mandatory. Then WHO proclamations will become legally binding. (Article 1) (Article 42)
- WHO can declare emergencies on potential, not just actual health concerns. (Article 2)
- Remove "respect for dignity, human rights, and fundamental freedoms of people" during cases of declared health emergencies. (Article 3)
- Enforce global health certificates, include vaccine passports and digital IDs. (Articles 18, 23, 24, 27, 28, 31, 35, 36, and 44. Also Annexes 6 and 8.)
- **Override the sovereignty of nations**. WHO's Emergency Committee will be the final decision makers regarding a nation's health measures. Goodbye DOH. Goodbye Senate. Goodbye House. Goodbye President. (Article 43)

WHO member nation states still need to finalize the IHR amendments drafted by the Working Group and analyzed by the Review Committee of the WHO. With significant issues at stake, as outlined above, it would be a prudent step for the Senate to **stop their approval process of SB1869. This will ensure that the Senate does not**

**inadvertently hand over control of Philippine sovereignty** in health matters over to a foreign entity like the WHO.

Next, the US Senators tackle the problems with the Pandemic Treaty.

The WHO's most recent publicly available draft of its new pandemic response treaty is **dead on arrival**. Instead of addressing the WHO's well-documented shortcomings, the treaty focuses on mandated resource and technology transfers, **shredding intellectual property rights, infringing free speech**, and supercharging the WHO. Moving forward with a new pandemic preparedness and response treaty ignores the fact that we are still unsure of COVID-19's origins because Beijing continues to block a legitimate independent investigation.... (Emphases supplied.)

The Senators then "strongly" stated that approving the Pandemic Treaty would require 2/3 of the votes in the Senate. If not, that would be in violation of Article 2 Section II of the US Constitution.

The US Congress has been having hearings on whether COVID-19 was made in a lab or whether it came from nature. The position of the US Senators in this case is cautious.

CCH has already shown that there is very strong evidence that COVID-19 came from a biolab. Here is what CCH wrote in its 1<sup>st</sup> Briefing Paper.

... Covid was a staged event. The evidence is now very clear that the US Department of Defense initiated the research program on creating the Covid "virus" and, for whatever reason, partnered with the Wuhan BL4 Lab in China to weaponize the coronavirus or segments of it. Admissions to this effect are far and wide, including revealing hearings in the US Congress and the release, via Freedom of Information requests and Congressional hearings, of confidential documents from the US Department of Defense. (Emphases in the original.) (Sources of the confidential documents cited in the Briefing Paper.)

The Senators conclude their letter to President Biden thus:

In light of the **high stakes for our country** and our constitutional duty, we call upon you to (1) **withdraw your administration's support** for the current amendments to the IHR and the pandemic treaty negotiations, (2) **shift your administration's focus to comprehensive WHO reforms** that address its persistent failures without expanding its authority, and (3) should you ignore these calls, **submit any pandemic related agreement to the Senate** for its advice and consent. Dear Mr. President:

Next month, during the Seventy-seventh World Health Assembly (WHA), your administration is expected to commit the United States to two international agreements that would strengthen the World Health Organization's (WHO) authority to declare public health emergencies of international concern and expand the WHO's authority over member states during such emergencies. This is unacceptable.

The WHO's failure during the COVID-19 pandemic was as total as it was predictable and did lasting harm to our country. The United States cannot afford to ignore this latest WHO inability to perform its most basic function and must insist on comprehensive WHO reforms before even considering amendments to the International Health Regulations (IHR) or any new pandemic related treaty that would increase WHO authority. We are deeply concerned that your administration continues to support these initiatives and strongly urge you to change course.

Article 55 of the IHR requires the text of any IHR amendment to be communicated to member states at least four months before the WHA at which they are to be considered. As the WHO has still not provided final amendment text to member states, we submit that IHR amendments may not be considered at next month's WHA. Some of the over 300 proposals for amendments made by member states would substantially increase the WHO's health emergency powers and constitute intolerable infringements upon U.S. sovereignty. As such, it was essential that the WHO abide by the four-month notice period to allow member states time to ensure that no traces of such proposals were included in a final amendment package for consideration by the WHA. Having failed to do so, amendments are not in order.

The WHO's most recent publicly available draft of its new pandemic response treaty is dead on arrival. Instead of addressing the WHO's well-documented shortcomings, the treaty focuses on mandated resource and technology transfers, shredding intellectual property rights, infringing free speech, and supercharging the WHO. Moving forward with a new pandemic preparedness and response treaty ignores the fact that we are still unsure of COVID-19's origins because Beijing continues to block a legitimate independent investigation. We strongly urge you not to join any pandemic related treaty, convention, or agreement being considered at the Seventy-seventh WHA. Should you ignore this advice, we state in the strongest possible terms that we consider any such agreement to be a treaty requiring the concurrence of two-thirds of the Senate under Article II Section 2 of the Constitution.

In light of the high stakes for our country and our constitutional duty, we call upon you to (1) withdraw your administration's support for the current IHR amendments and pandemic treaty negotiations, (2) shift your administration's focus to comprehensive WHO reforms that address its persistent failures without expanding its authority, and (3) should you ignore these calls, submit any pandemic related agreement to the Senate for its advice and consent.

SB1869 intends to place the Philippines under the control of the World Health Organization (WHO) in the event of a global pandemic. SB1869 also intends to strengthen the DOH on the assumption that DOH did a good job in managing the Covid crisis in our country. **But what if the country's Covid response was a massive failure**?

#### House Hearings on RP Excess Deaths and WHO Agreements

On March 19, 2024, Nicanor Perlas of CCH testified before the joint Hearings of the House Committee on Public Order and Safety and Committee on Human Rights. This hearing was pursuant to the Committees' legislative inquiry on House Resolution No. 1481. This resolution deals with the excess deaths recorded in the Philippines as well as the two WHO agreements discussed above.

Those hearings lasted more than four hours and covered an enormous amount of important subjects. Here is the link to full text of HR No.1481.<sup>5</sup> It would be instructive for the Senate staff to take a closer look at the transcript of these hearings as they reveal a lot of information that is of direct relevance to SB 1869.

For one thing, the statistician from the Philippine Statistics Authority verbally confirmed that, indeed, 297,000 excess deaths have devasted the Philippines. These are not Covid deaths. Most of the deaths cannot be explained by DOH and other Philippine government representatives who were there during the hearings.

This Hearing in the House is part of a global trend of hearings being done by legislators around the world. The topic on deaths due to the Covid vaccines and the trap of the WHO agreements has moved from "conspiracy theory" to urgent legislative inquiry in many countries around the world.

#### SCIENTIFIC CONFIRMATION OF COVID VACCINES DEATHS CONTINUE

Before looking at these new scientific findings, CCH would just like to refresh the memory of Senators regarding scientific evidence that Covid vaccines killed millions of people around the world.

#### Previous Scientific Evidence that Covid Vaccines Killed People

The scientific evidence for these deaths was already provided in Briefing Paper No. 4.6

• Unprecedented and rare record-level data released by New Zealand's top government administrator of said data revealed that, at least, 12,000 citizens were killed by the Covid vaccines.

- Using the New Zealand data, and combining this with other reputable data sources
- Steve Kirsch, MIT billionaire turned Covid researcher, calculated that the **Covid** vaccines killed 1 person per 1000 doses. In the US, that would mean the Covid vaccines killed 675,000 Americans. Globally, using this factor, Covid vaccines killed around 13 million people around the world.
- DOH's FDA gave the figure of 181,645.251 million doses as of September 30, 2023 report.9 Using the Kirsch factor cited above, this translates to approximately 181,000 Filipino deaths due to the Covid vaccines.

# Newly Released 2024 US Gov't Data Reveal Huge Numbers of Deaths due to Covid Vaccines

Medicare is a US federal government program of the U.S. Centers for Medicare and Medicaid Services. It provides "health insurance for people 65 or older", people with disability and "End-Stage Renal Disease", among others.<sup>7</sup> As part of its program, it gathers health data from those who have successfully applied for their programs.

A recent analysis of **never-before released data of Medicare** revealed that the **COVID vaccines have killed 350,000 people in one year.**<sup>8</sup> This is significant because the **sample size of the Medicare data is 23 million out of 60 million members. It must be noted that the actual deaths must be higher** because Medicare only covers those who are 65 years or older and/or people with disability.

## Statistical Survey Point to Similar Deaths due to Covid Vaccines

What this study a fluke? Apparently not. A 2024 survey showed the alarming experience of large numbers of Americans who thought there is evidence that the Covid vaccines killed their family or friends.

Steve Kirsch engaged a professional market research expert, Leonard Murphy, to do a scientific survey about vaccine injuries and deaths in American households. The survey interviewed 1,000 American households. One hundred ninety-four (194) of the 1,000 households surveyed, reported a death in their household since 2021. "**Nearly half of the respondents thought the death was due to the COVID vaccine**." (Emphases supplied.)<sup>9</sup>

## Affirmation of Earlier Research that Covid Vaccines Kill

These findings are not surprising at all. They merely affirm earlier findings since 2021 that CCH has already detailed in its Cease-and-Desist Letter and Supreme Court Petition.

In a larger study, published on **September 17, 2023** by Dr. David Rancourt, data from seventeen countries, including the Philippines, were examined. Here are the shocking results.

"We quantify the overall all-ages vDFR [Vaccine Death Fatality Rate] xxx for the 17 countries to be  $(0.126 \pm 0.004)$  %, which **would imply 17.0 ± 0.5 million COVID-19 vaccine deaths worldwide**, from 13.50 billion injections up to 2 September 2023. This would correspond to a mass iatrogenic [physician-caused] event that killed  $(0.213 \pm 0.006)$  % of the world population (1 death per 470 living persons, in less than 3 years), and did not measurably prevent any deaths.<sup>10</sup>

On **November 19, 2023**, a review was done of researches that conducted actual autopsies to determine cause of death. The finding?

"Our systematic review [published in the scientific platform, Zendo] finds that **the vast majority of deaths following the COVID mRNA gene vaccine are tied to the vaccine itself! 325 autopsies** (Nicolas Hulscher et al.); 240 deaths (73.9%) were independently adjudicated as directly due to or significantly contributed to by COVID-19 vaccination. most implicated organ system in COVID-19 vaccine-associated death was the cardiovascular system.<sup>11</sup>

In this context, and as a prelude to our next topic, it is highly significant that Sweden had the lowest rate of excess deaths in Europe. Sweden had no lockdowns, schools were opened, and had no forced vaccine mandates. Yet excess deaths in that country were not alarming. <sup>12</sup>

There are different authoritative studies showing the tsunami of deaths due to Covid vaccines. They cover different circumstances, age groups and other categories. But they all come to one conclusion. The Covid vaccines are not safe and effective. They have killed millions of people and should immediately be removed immediately by all governments around the world.

Dr. Pierre Kory, one of the world's foremost authority on Ivermectin, recently reported on his Op-Ed piece in the Hill, a Washington DC mainstream publication that is read by the vast majority of Congressional staffers and their principals. In "... just the first 9 months of 2023, 158,000 more Americans have died than expected, **what we call** "**excess deaths**." That "exceeds the combined deaths from every war since Vietnam." (Dr. Kory Substack article of December 15, 2023.) Life insurers have been consistently sounding the alarm over these unexpected or, "excess," deaths. Dr. Kory urged

Congress to "urgently work with insurance experts to investigate this troubling trend. Kory. *Ibid*.

Marshalling the findings of New Zealand and the US and elsewhere, there is strong evidence that the culprit for these excess deaths is the Covid vaccine. If they are not, the Senate should continue investigate what on earth is going on. For as pointed out in an earlier Briefing Paper on SB1869,<sup>13</sup> even the WHO has calculated that the **global** excess deaths have reached 14.83 million.<sup>14</sup>

Can we easily forget the lying assurances of the DOH that the vaccines are safe and effective when even *The Economist* estimates that excess deaths in 2022 were around 20 million people worldwide.<sup>15</sup>

The costs far outweigh the benefits. The world experienced around 13 to 17 million excess deaths that are strongly associated with the rollout of mandatory vaccinations. Meanwhile, members of UK Parliament are demanding their health agency to release internal data regarding excess deaths. (Dr. Meryl Nass, March 3, 2024)

#### Action Needed by Philippine Senate

Based on all the above scientific evidence and the impending dangers to our democracy, sovereignty, privacy, health. Human rights and freedoms, we strongly urge the Honorable Senators of the Republic immediately to:

- Stop the enactment of SB 1869 into law.
- Draft a letter informing President Ferdinand R. Marcos, Jr. to order his officials to withdraw from the negotiations that would lead to the forced approval of the fraudulent WHO amendments to the IHR and the proposed Pandemic Treaty.

Both deeds will require courage from the Honorable Senators. You will now need to be strong to defend the country from intrusion and control by predatory world powers. The WHO and the forces that control it are seeking to force outrageous agreements down the throats of people all over the world. These agreements have nothing to do with health. They have everything to do with controlling, forever, the fate of nations and humanity.

Be the best of what you can all be. Be true patriots and defend your country.
