COVID VACCINES HARMED 500 MILLION PEOPLE. ASTRA ZENECA REMOVES COVID VACCINE WORLDWIDE

WHO FAILS TO PASS A FINAL DRAFT PANDEMIC AGREEMENT YET RESORTS TO HYBRID (BACKDOOR AND UNTRANSPARENT) NEGOTIATIONS TO TRICK MEMBER STATES

Alarming global developments point to the wisdom of not enacting SB1869 into law.

- The top legal heads of 22 US States want US to pull out of WHO Agreements.
- New scientific evidence indicates that over 500 million injured by Covid vaccines
- Astra Zeneca admits it vaccines cause heart disease and pulls out its Covid vaccine from the global market.
- WHO negotiations fail to produce a final draft of a Pandemic Agreement. WHO adopts illegal procedures to fool member states into signing flawed Agreements.
- New study from the University of Leeds show there is no worsening threat of pandemics to justify rushing approval of WHO Agreements.

22 US Attorney Generals: Do Not Approve the WHO Agreements

In Covid Call to Humanity Briefing Paper, No. 5,¹ we informed the Honorable Senators that 49 US Senators wrote US President Biden to instruct US officials not to accept the two WHO Agreements. This includes rejection of the proposed amendments to the International Health Regulations that is a prominent feature of SB1869.

Now, twenty-two (22) Attorney Generals, almost half of all the chief legal officers of the US, just rejected both WHO Agreements. In a letter to US President Joe Biden, they wrote:

As the chief legal officers of our States, we oppose two instruments under negotiation that could give the World Health Organization (WHO) unprecedented and unconstitutional powers over the United States and her people. **Justice Neil Gorsuch remarked that the COVID-19 pandemic may have been ‘the greatest intrusions on civil liberties in the peacetime history of this country.’**... Meanwhile, the WHO failed to hold the Chinese Communist Party accountable for its lies and deceptions during the pandemic. ... Rather than learning from these failures, some inexplicably want to relinquish more power to unelected and unaccountable institutions. (Emphases supplied.)

Ultimately, **the goal of these instruments isn’t to protect public health. It’s to cede authority to the WHO ... to restrict our citizens’ rights to freedom of speech, privacy, movement (especially travel across borders) and informed consent.**² (Emphases supplied.)

CCH encourages the Honorable Senators to read the letter in full as the mainstream media virtually no longer cover very important developments of this nature for reasons we elaborated in Briefing Paper #4.³

Why are US Senators and the top legal officers of the US rejecting the WHO Agreements? There are a number of reasons which CCH has gone in great details in its five (5) Briefing Papers given to the Senators.

But the most important reason for rejection is the massive failure of the WHO to protect the health and safety of millions of people around the world. If it failed miserably, why grant the WHO more powers. This can only lead to more abuse.

Over Five Hundred Million Seriously Injured by Covid Vaccines. Pfizer Confidential Document Provides the Foundational Facts

A prestigious medical doctor has revealed that the Covid vaccines has an **injury-to-kill ratio of 34.4**. With this ratio, **the Covid vaccines have most likely seriously injured over half a billion people**.

The medical doctor who revealed this injury-to-kill ratio is James A. Thorp, MD. Dr. Thorp is a well-known Maternal-Fetal Medicine Specialist. He has authored over 250 academic publications.⁴ He has received honors and awards by three major institutions in his field. These are the American College of Obstetrics and Gynecology, the American Board of Obstetrics and Gynecology, and the International Society for Maternal Fetal Medicine. He also sat in the Boards of these three organizations.⁵ In short, Dr. Thorp has a solid scientific, medical and academic background.

Dr. Thorp recently gave an unprecedented interview featured in X.⁶ There he laid out a discovery that could forever change the discourse on Covid vaccine injuries. In this interview of almost an hour, Dr. Thorp explained his finding of the injury-to-kill ratio of the Covid vaccines.

One of his key documents to support his discovery is a thorough analysis of a Pfizer confidential document. Pfizer had an internal report to the US FDA. In a court case, Pfizer tried to hide this document for 75 years. The Court denied their Motion. They had to release this document to the public.⁷

The document revealed that Pfizer received 42,086 reports of serious injuries from its Covid vaccines around the world. The document also showed that the reports attributed 1,223 deaths due to the Pfizer Covid vaccine.⁸

From this information, Dr. Thorp obtained the Injury-to-Kill ratio for Pfizer's Covid vaccines. He obtained this by dividing 42,086 injuries by 1223 deaths. The ratio is 34.4. That is, for every one person killed by the Covid vaccines, 34.4 suffered serious injuries.

Globally, this would mean the following. CCH cited the scientific evidence that the Covid vaccines killed 17 million people.⁹ If one multiplies 17 million by 34.4, one obtains 584,800,000 seriously injured by the Covid vaccines.

The Covid vaccines killed millions and harmed hundreds of millions. Many countries followed WHO advise on their Covid response. WHO failed miserably. It is not any wonder why member states are questioning agreements that are contentious, vague and rushed.

Astra Zeneca Pulls Out Its Vaccines

Amidst all these, Astra Zeneca is sensing the winds of change. It pulls out its vaccine worldwide while it had a court case against it. The company claimed that its Covid vaccine has been superseded by an alternative. But it is clear that the trigger for the worldwide recall is its admission that its vaccines can cause a “rare” heart disease.¹⁰

WHO Fails to Produce Final Draft of Pandemic Agreement

Despite one week of overtime work, WHO admitted that it failed to produce a final draft of the Pandemic Agreement. WHO had hoped to produce a consensus draft agreement for consideration by the World Health Assembly in its upcoming meeting starting May 27.

In its news release on May 10, 2024,¹¹ WHO spun the failure in a more positive light.

Governments of the world today agreed to continue working on a proposed pandemic agreement, and to further refine the draft, ahead of the Seventy-seventh World Health Assembly that starts 27 May 2024.

‘During more than two years of intensive negotiations, WHO’s Member States have shown unwavering commitment to forging a generational agreement to protect the world from a repeat of the horrors caused by the COVID-19 pandemic,’ said Dr Tedros Adhanom Ghebreyesus, WHO Director-General. ‘I welcome the determination that all countries have shown to continue their work and fulfill the mission on which they embarked.’

The absurdity of such a statement can be seen when one understands that the International Negotiating Body (INB) for the Pandemic Agreement had tried for two years to come up with a Pandemic Agreement. They also had to extend for one week their 9th INB negotiations because of contentious and sticky issues around key issues, especially Article 12 of the Pandemic Agreement.¹²

Within their own rules, they have no authority to further refine the draft any further. Its sister Agreement, the Amendments to the International Health Regulations (IHR) views a reasonable deadline as four months before an upcoming World Health Assembly.¹³ Forcing a draft in a few weeks and expecting government officials to approve this in a few days would be tantamount to insulting the representatives of Member States. No honest person would do that in contentious international negotiations.

This is clearly a set up by an organization more interested in gaining the power and control that the Pandemic Agreement would give them. This is absolutely not about the health of the world. This is a reality CCH has been warning about in its past Briefing Papers and one that 22 US Attorney Generals also cite in their letter to President Biden. (See above.)

Leeds University Shows No Real Urgency for a Pandemic Agreement

All throughout this process, there has been messaging regarding the urgency of crafting a Pandemic Agreement.¹⁴ Yet a new 117-page scientific study by scientists at the University of Leeds demonstrates that no such emergency exists to justify WHO rushing a flawed agreement.¹⁵ Here is what the scientists and researchers found out.

The report finds that the data and evidence is poorly supportive of current pandemic risk assumptions, suggesting that **the urgency is unwarranted** and that more time is required to formulate policy that reflects the true risk of pandemics in the wider healthcare context. (Emphases supplied.)

In contrast, the data suggests that an increase in recorded natural outbreaks could be largely explained by technological advancements in diagnostic testing over the past 60 years, while current surveillance, response mechanisms and other public health interventions have successfully reduced burden in the past 10 to 20 years. COVID-19, if indeed of natural origin, appears as an outlier rather than part of an underlying trend. (Emphases supplied.)

The only item in this study that is not accurate is that COVID-19 is not of natural origin. As already detailed in past Briefing Papers, COVID-19's origin came from a lab.¹⁶ It is a product of gain-of-function research or genetic engineering.¹⁷ Whether it escaped from a lab or released from a lab is now the issue.

SB1869: Wrong Side of History

Dear Honorable Senators, you all had good intentions in crafting SB1869. However, events in the past year, clearly show that the response of DOH and WHO to COVID-19 is deeply flawed. We have shown this in the past five (5) Briefing Papers we sent you.
